

**JOINT VENTURE CONTRACT BETWEEN INHORES AND ACCOMMODATION FACILITIES FOR SCHEDULING ONLINE HOTEL BOOKINGS AND PROVIDING ACCOMODATIONS TO MUTUAL CLIENTELE VIA THE INHORES ONLINE SALES SYSTEM**

**1. PARTIES TO THE CONTRACT**

The party of the first part to this contract is the commercial entity *İnternet Otel Rezervasyonları ve Otelcilik Truizm Seyahat Acenteleği Pazarlama Limited Şti.*, Trade Registration Number 776946, a company performing online-sales and hereinafter referred to as INHORES. The INHORES headquarters address is *İskenderpaşa Mahallesi Macar Kardeşler Caddesi*, No 49, Kat:3 D:3, Postal Code 34080, in the district of Fatih, in the city of İstanbul, in the Republic of Turkey. INHORES, Tax Registration Number 4780524839, is registered for taxation purposes at the *Fatih* Tax Office in the district of Fatih, in the city of İstanbul, in Turkey.

The party of the second part to this contract is the commercial entity, ....., Tourism Ministry Registration Number ....., hereinafter referred to as the HOTEL or the ACCOMMODATION FACILITY, whose registered headquarters address is .....

The party of the third part is INHORES and the ACCOMMODATION FACILITY'S mutual clientele, hereinafter referred to as the GUEST or GUESTS, who engage the services of INHORES and the ACCOMMODATION FACILITY via the INHORES online booking-system.

The signatories further declare that they have signed this contract of their own volition in their respective official capacities as the legally authorized representatives of the aforementioned parties. GUESTS shall have been considered to have given their consent to enter into and as having entered into this contract of their own volition upon submitting their credit card numbers into the INHORES Online Booking-system.

**2. GENERAL DUTIES OF THE PARTIES**

A. INHORES shall provide the ACCOMMODATION FACILITY with online-bookings at the ACCOMMODATION FACILITY whenever such bookings are available while this contract.

B. The ACCOMODATION FACILITY, ....., is currently in and shall continue to be maintained in a state which enables the ACCOMMODATION FACILITY to provide the above mentioned accommodations to mutual clientele booked on behalf of the ACCOMMODATION FACILITY by INHORES. The ACCOMMODATION FACILITY shall accept INHORES clientele at its facility.

C. The parties named herein hereby declare that they shall jointly undertake the duties delineated above in Articles 2A and 2B. The parties additionally agree to the mutual use of their respective resources in this joint venture as specified elsewhere herein.

**3. SPECIFIED DUTIES OF THE PARTIES**

A. INHORES, which is the booking agency, shall undertake to provide the following service. INHORES shall enter the ACCOMMODATION FACILITY into its computer system to enable GUESTS to book accommodations through the INHORES online booking-system. (Resources: INHORES software/web-pages)

B. The HOTEL, the accommodations provider, shall undertake the following services.

- (1) Provide all information required by INHORES to enable it to market activities and accommodations available at the HOTEL on the INHORES web pages.
- (2) Reserve a minimum of one room (one vacancy) for INHORES every day for one year starting on the effective date of this contract. The HOTEL has the option to not reserve the minimum one-room vacancy for a total of three (3) days, either consecutively or separately, by logging in to the INHORES online-system using the HOTEL'S user-name and password via the 'HOTELS' section. The ACCOMMODATION FACILITY shall not otherwise alter the one-room vacancy quota.
- (3) The HOTEL is authorized to increase the number of its assigned rooms or cancel accommodations reserved for INHORES provided that INHORES is notified of the cancellation on the cancellation date or earlier.
- (4) The ACCOMMODATION FACILITY shall register its HOTEL on the INHORES online-system within 48 hours of the signing of the contract. Registration shall include at least the minimum one-room vacancy, prices, descriptions of the rooms, amenities, and available activities and any additional information about future bookings at the HOTEL.
- (5) If the check-in date of a booking made before the expiration date of the contract will be after the expiration date of the contract, the HOTEL must accept the confirmed booking.
- (6) All contractual obligations between the GUEST and the HOTEL, unless otherwise explicitly stated herein, shall be solely between the HOTEL and the GUEST after the booking has been confirmed by the GUEST and the HOTEL.

#### **4. SERVICE CHARGE AND PAYMENT METHOD**

A. The HOTEL, having allocated at least one room for INHORES for a minimum of one year as aforementioned in Clause (2) of Article 3B, shall obtain the entire INHORES booking fee, hereafter referred to as the service charge, from the GUEST on behalf of INHORES during the GUEST'S stay at the HOTEL. The HOTEL shall record its receipt of the INHORES service charge by preparing an invoice and sending it to INHORES for verification.

B. INHORES shall verify the booking-dates and other relevant details recorded on the invoice.

C. All correspondence regarding bookings and service-charge billing between the GUEST, ACCOMMODATION FACILITY, and INHORES shall be via email.

D. The booking and order numbers shall constitute the HOTEL'S authorization to add the INHORES service charge, which shall be fifteen percent (15%) of the total cost of the GUEST'S accommodations at the HOTEL during the GUEST'S stay, to the GUEST'S bill and to charge the sum of these two costs to the GUEST at check-in time. INHORES shall prepare and submit an invoice to the HOTEL for its commission. The prices which are being advertised online by the ACCOMMODATION FACILITY at the time the reservation is made shall apply. Subsequent price increases shall not apply to GUESTS who have a confirmed reservation which was made before the price increase.

E. In the event the HOTEL cannot provide the GUEST with accommodations as result of double-booking or overbooking, the HOTEL shall be responsible for arranging accommodations for the GUEST at a HOTEL of equal or higher quality. The ACCOMMODATION FACILITY shall also pay for the entire cost of accommodations at the equal or higher category HOTEL where the GUEST shall be accommodated as a pecuniary penalty for double or overbooking. The HOTEL shall be solely liable for all legal pecuniary and non-pecuniary damages that result from nonpayment of the entire cost of the inconvenienced GUEST 's accommodations.

## **5. RIGHTS AND RESPONSIBILITIES OF INHORES TO THE ACCOMMODATION FACILITY AND GUEST**

INHORES shall undertake the following:

A. Pursuant to the provisions of this contract as heretofore stipulated herein, INHORES shall have the right to use the intellectual property rights of the HOTEL on the INHORES online system, including INHORES web-pages which are publicly viewable.

B. The ACCOMMODATION FACILITY, as stipulated above, grants INHORES the right to utilize, reproduce, and copy information pertaining to the HOTEL for market purposes.

C. The ACCOMMODATION FACILITY, as aforementioned in Clause 5A above, grants INHORES, which is an abbreviation of *ONline HOliday REServation* and operates in conjunction with INHORES, the right to utilize, reproduce, and copy information pertaining to the HOTEL for marketing purposes.

D. INHORES shall inform the ACCOMMODATION FACILITY of bookings and cancellations pertaining to the ACCOMMODATION FACILITY on its online booking-system and changes to the online system which affect the ACCOMMODATION FACILITY in the shortest time possible.

E. INHORES shall electronically send (1) the dates booked, (2) the daily accommodation price, (3) the name, address, and email address of the HOTEL where the GUEST shall be staying, and (4) the booking form (receipt) containing the total amount to be paid to the HOTEL by the GUEST to the GUEST.

F. INHORES shall simultaneously electronically transfer this information to the ACCOMMODATION FACILITY in order to prevent double-booking by the ACCOMMODATION FACILITY.

G. The ACCOMMODATION FACILITY shall not provide a GUEST'S credit card data to its financial service provider or institution for processing and collection of booking fees before the herein stipulated (24-hour), (48-hour), (72-hour), (96-hour), (120-hour), (144-hour), (168-hour) time-period, which begins when GUESTS enter this data into the INHORES online-system, has elapsed in order to prevent violations of the GUEST'S right to purchase without obligation. The aforementioned rule shall not apply in those cases in which the late-cancellation provisions are applicable. The ACCOMMODATION FACILITY may only verify the credit card data of the GUEST via its financial service provider or institution.

H. INHORES shall incur no liabilities that may result from temporary or partial service outages, errors on any other Internet site and/or external networks. INHORES shall undertake to protect the identities, credit card data, addresses, and mail and telephone information obtained from the GUEST in accordance with standard business practices and shall comply with applicable privacy laws while operating its online system. INHORES otherwise accepts responsibility for safeguarding the information provided to it by its GUESTS.

## **6. RIGHTS AND RESPONSIBILITIES OF THE ACCOMMODATION FACILITY OR HOTEL TO INHORES AND GUESTS**

A. The ACCOMMODATION FACILITY shall submit its national and municipal business operators licenses and its Turkish Tourism Ministry Tourism Operators License to INHORES to enable INHORES to comply with applicable Turkish Laws and pursuant to contractual provisions herein. The ACCOMMODATION FACILITY further declares that it grants INHORES authorization to review the aforementioned licenses at will while this contract remains in effect.

B. The ACCOMMODATION FACILITY shall provide all information including, but not limited to, the ACCOMMODATION FACILITY'S commercial title, address, photographs of the facilities, services it

provides to its GUESTS, prices, and information pertaining to all cancellation and no-show policies, as may be required by INHORES to market the facility on INHORES web-pages. The HOTEL hereby declares that it is solely responsible for the accuracy of this information. The HOTEL further hereby grants authorization to INHORES to abbreviate and translate the information it provides into foreign languages as may be necessary pursuant to the aforementioned marketing purposes.

C. The ACCOMMODATION FACILITY hereby declares that it shall allocate a minimum of one room to INHORES for one year as stipulated elsewhere herein, and further grants authorization to INHORES to obtain information as stipulated elsewhere herein from its web page to include, but not limited to, logos, brand names, photographs and images, videos, prices and ancillary prices pertaining to those rooms allocated by the HOTEL to INHORES pursuant to the provisions of this contract.

D. The ACCOMMODATION FACILITY shall have the right to enter into contracts with parties of the fourth part, hereafter referred to as OTHER PARTIES, FOURTH PERSONS, or 4<sup>TH</sup> PERSONS, should this becomes necessary in order to remain in compliance with the provisions of this contract. The ACCOMMODATION FACILITY hereby declares that it shall undertake to ensure that the prices negotiated in the aforementioned contract with OTHER PARTIES shall be equal to the prices offered to INHORES to ensure that the best possible price shall be offered to the mutual clientele of the ACCOMMODATION FACILITY and INHORES. The ACCOMMODATION FACILITY hereby declares that not negotiating and not providing an equal price between all parties shall be an unfair business practice pursuant to the provisions of this contract. The ACCOMMODATION FACILITY further hereby agrees that it shall return the price differential to the GUEST in the event the ACCOMMODATION FACILITY is unable to obtain an equal price pursuant to the provisions of this contract,

E. INHORES shall provide the following to the ACCOMMODATION FACILITY whenever (1) the ACCOMMODATION FACILITY increases the number of rooms allocated to INHORES for one year and also (2) increases the 15% service-charge stipulated elsewhere herein as follows:

- (1) The HOTEL shall be entitled to be listed in the "ADVANTAGEOUS" section of the INHORES website as one of the "Hotels of the Day" whenever the ACCOMMODATION FACILITY increases the number of vacancies to be advertised daily on the INHORES website to ten (10) vacancies.
- (2) The HOTEL shall be entitled to be listed in the more advantageous and prestigious section of the website, "Hotels of the Week," whenever the ACCOMMODATION FACILITY increases the 15% minimum service-charge and also increases its daily vacancy listing from one (1) to ten (10) vacancies.
- (3) The aforementioned increases in the number of additional rooms allocated to INHORES, and to the service charge provided by the ACCOMMODATION FACILITY to INHORES, shall not obligate INHORES to list or otherwise advertise the rooms offered for sale. The ACCOMMODATION FACILITY hereby declares its acceptance of this stipulation.
- (4) INHORES shall have sole authority to determine the eligibility of any HOTEL or ACCOMMODATION FACILITY to be placed in the "ADVANTAGEOUS" sections of INHORES web pages.

F. The ACCOMMODATION FACILITY shall honor all confirmed bookings and shall consequently accept check-ins from GUESTS who have confirmed booking-dates for dates that are after the expiration date of this contract.

G. The ACCOMMODATION FACILITY shall be responsible for logging onto the INHORES Online Booking System, using the username and password provided by INHORES, and entering the following pursuant to the provisions of this contract: (1) the rooms that shall be advertised on the INHORES website, (2) the specifications of these aforementioned rooms, (3) service-charge ratios, (4) vacancy and unavailability dates, (5) any subsequent updates or changes to the aforementioned, and (6) reviewing the aforementioned information to ensure that is accurate on a daily basis.

The ACCOMMODATION FACILITY hereby declares that it shall bear sole responsibility for double-bookings or over-bookings, and further declares that it shall accept sole liability for all GUEST complaints, that may arise from the ACCOMMODATION FACILITY'S failure to update the aforementioned information in a timely manner, which shall be forty-eight hours (48-hours), pursuant to the provisions of this contract. The ACCOMMODATION FACILITY further hereby declares that it shall charge the GUEST the price shown online at the time the GUEST confirmed the booking in the event that there is a price differential that is a result of the ACCOMODATION FACILITY'S failure to update the aforementioned information in a timely manner.

The ACCOMMODATION FACILITY hereby acknowledges the right of INHORES to change the online prices posted by the ACCOMMODATION FACILITY to bring the prices into compliance pursuant to the provisions of this contract forty-eight hours after the ACCOMMODATION FACILITY has posted them to the INHORES website.

H. The ACCOMMODATION FACILITY shall charge the lowest of the prices advertised on its website, other websites on which it advertises, and those given to INHORES. The lowest price available shall always be charged to GUESTS whether it shall have been advertised or not.

I. The HOTEL hereby declares that it shall not charge the GUEST using any name other than the name used to book the accommodations.

J. The HOTEL hereby declares that it shall bear sole responsibility for resolving disputes that may arise between the GUEST and the HOTEL that result from additional services promised or provided to the GUEST such as, but not limited to, external tours, transfers, entertainment activities or programs. The HOTEL further hereby declares that INHORES shall bear no responsibility or liability whatsoever in these disputes.

K. INHORES hereby declares that it shall charge neither the GUEST nor the HOTEL under any name other than the respective names used at the time the accommodations were booked.

L. The HOTEL hereby declares that it shall charge the accommodation and ancillary prices in effect at the time the reservation shall have been made to the GUEST, and further hereby declares that price increases which shall have been applied subsequent to the confirmation of the reservation shall neither be offered nor charged to the GUEST.

M. The HOTEL shall charge the GUEST on a non-refundable basis whenever a GUEST selects a discounted promotion package. The GUEST shall have neither the right to cancel a confirmed reserved discounted promotion package nor the right to a refund, the GUEST'S time-limited right to cancel without explanation notwithstanding, pursuant to the provisions of this contract.

N. The ACCOMODATION FACILITY shall have the option to request that INHORES add the ancillary hotels or accommodation facilities of the ACCOMMODATION FACILITY to this contract provided that the provisions of this contract shall be applied to the ancillary hotels or accommodation facilities in toto and without modifications.

## **7. RIGHTS AND RESPONSIBILITIES OF THE GUEST TO INHORES AND THE ACCOMMODATION FACILITY**

A. The GUEST shall provide the following: (1) identification documents, (2) credit card information, (3) billing address, (4) mailing address, and (5) a telephone number in order to receive INHORES services. The GUEST shall bear sole responsibility, and INHORES shall incur no liabilities whatsoever, for errors resulting from incorrect information provided to INHORES by the GUEST.

B. INHORES hereby declares its acceptance of responsibility for safeguarding the personal information provided to it by the GUEST. The ACCOMMODATION FACILITY hereby declares its acceptance of responsibility for safeguarding the personal information provided to it by the GUEST.

C. The HOTEL shall have the right to unilaterally cancel the reservation of the GUEST in the event the credit-limit of the credit card shall have been proved to be insufficient, the credit card invalid, or otherwise unacceptable.

D. The ACCOMMODATION FACILITY hereby acknowledges that it shall not charge any amount whatsoever to the GUEST'S credit card until after the time-period stipulated elsewhere herein (24-hour), (48-hour), (72-hour), (96-hour), (120-hour), (144-hour), (168-hour) has elapsed in order to ensure that the GUEST'S right to cancel a reservation without explanation is not violated. However, the aforementioned stipulation shall not apply when the GUEST'S cancellation is pursuant to the penalty clause stipulated elsewhere herein. The ACCOMMODATION FACILITY shall have the right to verify the validity of the credit card through its bank or financial institution.

E. The GUEST hereby acknowledges that the expiration date of the credit card that is used to book a reservation shall not be before the last day of the GUEST'S stay at the HOTEL. The GUEST further hereby acknowledges that in the event the credit card shall expire before the starting date of the GUEST'S stay, the entire amount due may be charged against the GUEST'S credit card.

F. The GUEST shall have the right to shorten the length of the stay upon or after check-in at the HOTEL pursuant to the provisions of this contract. The GUEST further acknowledges that in the event the GUEST does choose to shorten the length of his or her stay, the minimum service charge shall not be refunded. The GUEST shall also have the right to extend the stay at the hotel upon or after his or her arrival. In the event the GUEST extends the stay at the HOTEL, INHORES shall not request an increased or additional service-charge from the HOTEL or the GUEST.

G. The GUEST shall have the right to cancel or curtail the stay in the event the room or rooms are substandard or not as advertised. The GUEST further acknowledges that the HOTEL shall charge the GUEST pursuant to the provisions of this contract in these cases. The GUEST is hereby notified that that INHORES shall request its service charge from the HOTEL for the length of time which the GUEST shall have stayed or, in the event the GUEST shall have chosen not to stay at the HOTEL, INHORES shall request a service charge for a one-night stay from the HOTEL.

H. The HOTEL shall have the right to conduct a credit-check of the GUEST'S credit card during the applicable (24-hour), (48-hour), (72-hour), (96-hour), (120-hour), (144-hour), (168-hour) cancel-without-explanation time-period, but the HOTEL shall not have the right to charge any amount whatsoever against the GUEST'S credit card during this time-period. The HOTEL shall have the right to charge the GUEST'S credit card when the arrival time shall be less than the aforementioned time-periods in order to confirm and guarantee the GUEST'S reservation. The HOTEL shall have the right to unilaterally cancel the GUEST'S reservation in the event the credit-limit of the GUEST'S credit card is insufficient to cover the entire cost of the GUEST'S stay.

I. The GUEST hereby acknowledges that all discounted promotional packages on INHORES webpages shall be (1) nonrefundable and (2) shall not be subject to the cancel-without-explanation time-periods stipulated in paragraph H above. The GUEST further acknowledges that in the event the customer selects one of the aforementioned packages, (1) the GUEST'S credit-card shall be charged at the time the reservation is made by the GUEST, (2) the amount that shall be charged shall be nonrefundable, and (3) the amount that shall have been charged shall not be refunded in the event the GUEST cancels the reservation.

#### **(1) RIGHTS AND LIABILITES OF THE GUEST IN THE EVENT OF CANCELLATION BY THE GUEST**

(A) The GUEST acknowledges that he or she shall not be charged an accommodation fee, penalties, or forfeit the right to a refund by the HOTEL in the event the GUEST cancels a reservation within the (24-hour), (48-hour), (72-hour), (96-hour), (120-hour), (144-hour), (168-hour) cancel-without-explanation time-period (local time) as stipulated elsewhere herein, other HOTEL policies notwithstanding.

(B) The GUEST acknowledges that he or she shall pay for one night's accommodation in the event the GUEST cancels the reservation after the (24-hour), (48-hour), (72-hour), (96-hour), (120-hour), (144-hour), (168-hour) cancel-without-explanation time-period (local time) has elapsed as a late-cancellation penalty fee. All times shall be local-time at the HOTEL.

(C) The GUEST shall pay for two night's accommodation in the event the GUEST fails to notify the HOTEL of the cancellation (no-show) as a no-show penalty fee.

(D) The GUEST shall pay a one-night accommodation penalty fee in the event the reservation shall have been for a one-night stay. The two-night penalty shall not be charged to any GUEST whose booking is for one night only except as stipulated below.

(E) GUESTS whose stay is for two nights or longer shall be charged the two-night penalty fee. However, the aforementioned stipulation shall not apply in cases where the reservation was made on behalf of or by an international organization or congresses, for special days, and for discounted promotional packages. In such cases, the penalty shall be for the entire period of the stay.

F) If the customer or a member of the customer's immediate family meets one of the following conditions, or has been incarcerated, and has official, legally recognized documents which verify the incarceration or that he or she meets any of the conditions listed below, the customer may cancel the reservation without submitting payment of any kind whatsoever.

(1) Death

(2) Illness

(3) Temporary or permanent disability

(4) Has been involved in an accident which precludes travel of the customer

(5) Has had an involuntary change in job location of an immediate family member or the customer himself or herself, the circumstances of which preclude travel

## **8. ACKNOWLEDGMENT OF HAVING READ IN ITS ENTIRETY AND AGREEMENT TO THE TERMS OF THIS CONTRACT**

A. As stipulated in Article 1, this contract shall be in effect as of the date it has been signed by the parties named herein or their authorized proxies.

B. It is further declared that this contract shall be in effect upon being electronically shared by the ACCOMMODATION FACILITY or HOTEL, and the GUEST'S having acknowledged having read the contract in its entirety and subsequently clicking on the "I HAVE READ THE MEMBERSHIP CONTRACT; I AGREE" icon on the INHORES website to submit his or her credit-card data.

C. After this contract shall have been mutually or electronically brought into effect, any modifications or amendments hereto may be consented to electronically.

## **9. TERM OF THE CONTRACT**

The term of this contract shall be one (1) year from the effective date as stipulated in Article 8 above and shall apply to all parties except that those parties to whom to the joint venture sections of this contract shall pertain shall have the right to unilaterally terminate the joint venture thirty (30) days prior to the expiration date of this contract either electronically or in writing. Furthermore, in the event that neither party to the joint venture shall have acted to terminate the contract pursuant to the aforementioned stipulation, this contract shall be considered to have been mutually renewed by mutual agreement and shall remain in effect for the following year,

## **10. TERMINATION OF THE CONTRACT**

1. This contract shall be terminated by mutual agreement of the parties as stipulated at Article 9 above.

2. This contract shall be considered terminated should one of the parties to it violate its provisions either in part or in its entirety.

3. This contract shall be considered terminated whenever any party to this contract shall have entered into a state which precludes it from fulfilling its contractual obligations as stipulated herein.

4. In the event of natural disaster, war, or any other event or series of events over which any party has no control and which prevent any from honoring its contractual obligations.

## **11. COMMON PROVISIONS**

A. All parties to this contract shall be responsible for safeguarding the GUEST'S credit card data and shall undertake to exercise the utmost care to ensure the protection of this data at all times.

B. No party to the joint venture provisions of this contract shall have right to assign and/or transfer liabilities incurred herein to any other party without the written consent of the other party.

C. Commercial and legal actions and/or activities pursuant to this contract may be undertaken in any language. However, in the event of any dispute stemming from the meaning of the provisions of this contract, the Turkish Language shall be the acknowledged language for final and binding resolution.

D. Charges made to the credit cards of parties to this contract shall be made with the currency specified by the GUEST at the time the GUEST shall have made his or her reservation.

E. All parties hereby acknowledge that they shall comply with privacy laws to safeguard the information of other parties to this contract.

## **12. OFFICIAL ADDRESSES AND CORRESPONDENCE FORWARDED THERETO**

Correspondence pertaining to this contract shall be hand-carried, faxed, or forwarded by registered mail, public courier (e.g., 'FEDEX'), or via a notary public or civil-law notary to the addresses provided by the parties herein.

## **13. PARTIAL TERMINATION OF THE CONTRACT**

Should one or more provisions of this contract be made moot or otherwise nullified as a result of subsequent changes to a law or laws, the validity of the unaffected provisions of this contract shall

remain in effect. The invalidated clauses shall be replaced by the aforementioned changes to the laws herein, providing that the purposes and intentions of the parties to this contract shall not have been made moot or otherwise nullified. The parties named herein, having negotiated and entered into this contract, shall have the right to approve any subsequent modifications or amendments hereto and shall further have the right to give their consent to such modifications and amendments hereto electronically.

**14. POWER OF ATTORNEY AND SIGNATURE OF THE PARTIES**

The parties to the joint venture herein hereby authorize their attorneys, as well those to whom they may have granted powers of attorney, to sign this contract as their legal representatives.

**15- COMPETENT COURTS**

The parties hereby acknowledge that Istanbul Courts and Execution Offices shall adjudicate disputes under Turkish Law arising from this contract between INHORES and the ACCOMMODATION FACILITY.

Pursuant to Clause 3 B-3 herein, this contract shall be a contract solely between the HOTEL and the GUEST.

In the event of disputes between the HOTEL and the GUEST, Turkish law and the law of the nation in which the customer resides shall be applicable. In the event of differing verdicts, the judgments rendered in Istanbul courts and Execution Offices shall have take precedence and shall be legally binding.
